Fund Commentary

The Fund delivered a return of 0.3% in December. There were no notable contributions to this month's results, with all movements less than 0.4% and significant portion of the portfolio reporting little if any movement.

The Warrnambool Cheese & Butter Factory Holdings Limited (WCB) saga continued, with Canadian firm Saputo, altering its offer, following a Takeovers Panel application by Bega Cheese Limited, by increasing the cash price, confirming there would be no special dividend component and declared its offer final. This last part was a very disappointing development; notwithstanding WCB has been a very profitable investment for the Fund. Removing the prospect for a special dividend has, in our view, effectively short-changed Australian shareholders of imputation credits of at least 56 cents per share. By declaring the offer final, Saputo has no further means by which to vary the offer. We believe the special dividend may well have fallen victim to confusion and misunderstanding surrounding franking generally and the value of imputation credits in the hands of shareholders specifically. Subsequent to the month end, Bega announced it was accepting the Saputo offer, despite our attempts to convince Bega of the benefits of a special dividend.

We remain cautious about the global macro outlook, as market conditions remain fertile for sentiment to overshoot value (both up and down). The consequences of the significant macro factors at play globally are difficult to predict or quantify. We remain focused on opportunities that have high levels of tangible assets, marketable securities or cash and whose prospects are somewhat independent of market and economic conditions, as we believe these offer the best risk-adjusted returns in the current environment.

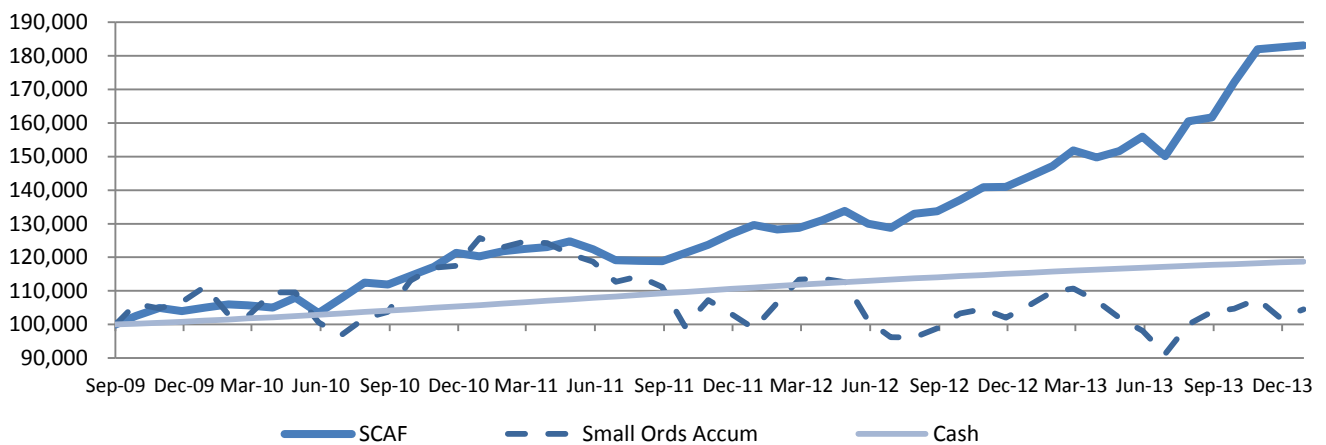

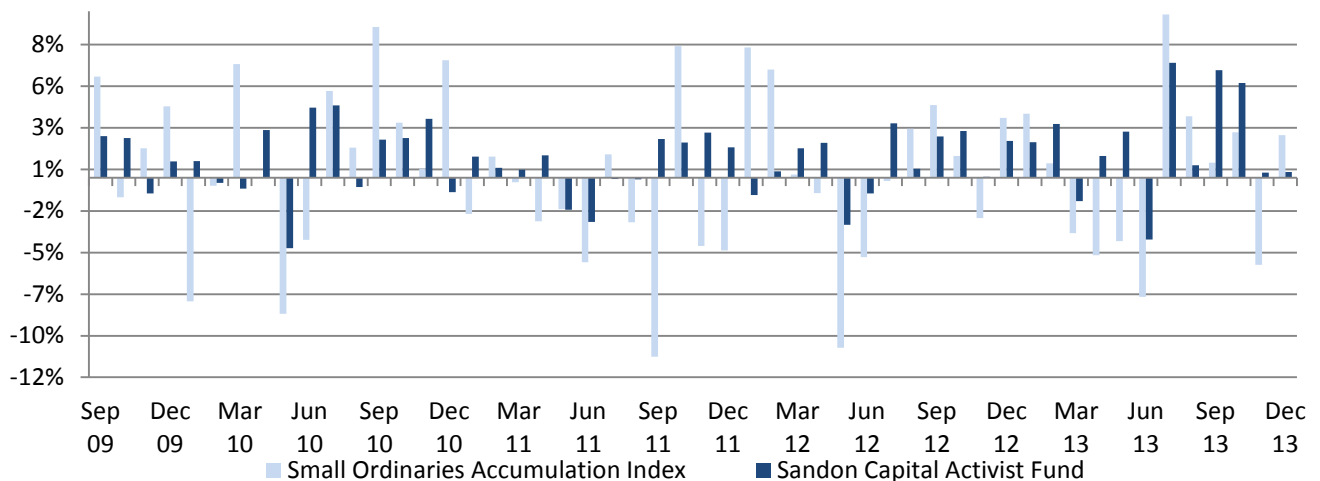

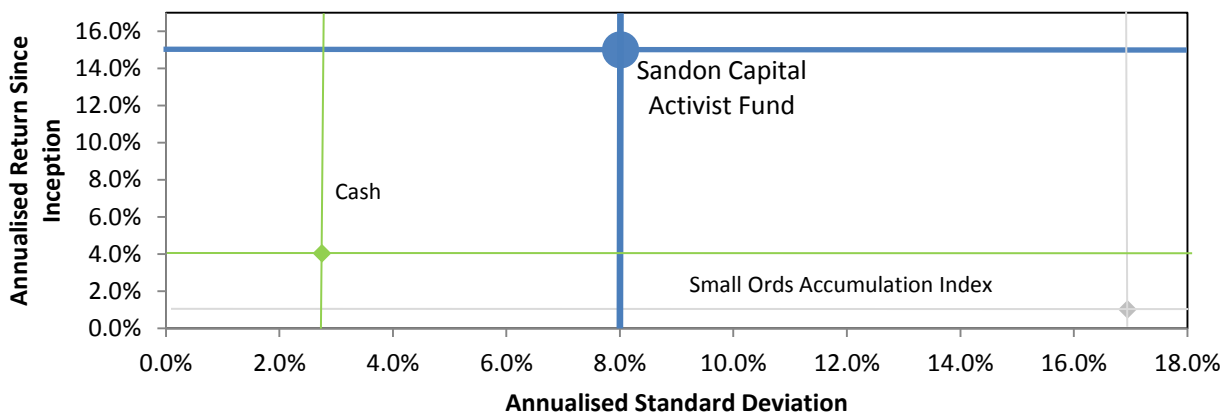
Growth of \$100,000 invested since inception (assumes reinvestment of distributions)
