Fund Commentary

The Fund delivered small positive return of 0.6% this month. Positive contributions included ING Entertainment Fund (~0.5%), Emerging Leaders Investments Ltd (~0.5%) and GPG Plc (~0.3%). Detractors included Adelaide Yield Trust (~-0.4%) and Gunns Limited (~-0.4%) and Tassal Ltd (~0.3%).

Tassal Ltd (TGR), a salmon producer, concluded a strategic review commenced in December last year. It considered a number of broad options, including continuing with current plans and selling itself. During the review process, Pacific Andes Resources Ltd, a Singaporean seafood company nabbed a 19.8% holding. The review led to a proposal from a private equity firm (following two rounds of due diligence) at an indicative price of \$1.90. The Board terminated those discussion (citing, inter alia, "key" shareholder price objectives as well as the Board's own view on price) instead of encouraging a bid to be put on the table for (all) shareholders to consider (somewhat of a recurring theme, viz Perpetual). The Board now have to demonstrate to shareholders how their plans will deliver more value than \$1.90 per share (with TGR shares now trading at ~\$1.55).

Warrnambool Cheese & Butter Factory (WCB) reported a half year net profit after tax of \$36.4 million (the Company had previously flagged a result of between \$35 and \$37 million) and announced a 4 cent per share fully franked dividend. Although marginally down month-on-month (~0.2%), WCB trades ~26% above our average purchase price.

The Fund held ~35% of its assets in cash and was unhedged against market movements. We remain cautious about the global macro outlook. There are significant macro factors at play globally, the consequences of which are difficult to predict or quantify.

We remain focused on opportunities that have high levels of tangible assets, marketable securities or cash, as we believe these offer the best risk-adjusted returns in the current environment.
