Fund Commentary

The Fund delivered a return of 3.2% in February. Returns this month were broadly spread, including a number of fully franked dividends. Performance highlights included Emerging Leaders Fund Ltd (ELI), an LIC whose share price and dividends contributed ~0.8% to this month's result. ELI also activated its dividend reinvestment plan (DRP) which allows shareholders to elect to have their dividend reinvested in shares at a 2.5% discount to a volume weighted share price. We believe this is a sub-optimal decision by the ELI Directors as when ELI shares trade at a discount to their net tangible asset backing, any shares issued under the DRP are dilutive to shareholders who don't or can't participate.

Calliden Group Ltd (CIX) announced its full year results and declare a small fully franked dividend (the first since 2011), which investors appeared to like (as its shares rose ~9% over the month). The CIX result indicated progress on the transition to lower risk agency business. Notwithstanding, CIX still exhibits, in our opinion, the hallmarks of a business whose strategy is borne of a fundamental lack of capital. From an investment perspective, if our view proves correct, then some form of corporate activity should be pursued, but if management proves us wrong with the success of their current strategy, the shares should do well as earnings grow and the company pays increasing dividends.

As we have noted previously, regulatory responses, especially unconventional monetary ones, can engender significant positive market responses (something we believe is happening now) but may not address root causes. The consequences of the significant macro factors at play globally are difficult to predict or quantify.


