Fund Commentary

The Fund delivered a return of 1.6% in February. The largest contribution to this month's return (~0.9%) arose from our exit from a position built in Keybridge Capital Limited (KBC), which was the subject of a foiled takeover attempt by a substantial shareholder Oceania Capital Partners Limited (OCP). The Fund exited its holding at 19.5 cents per share, above the takeover price of 19 cents per share, prior to the takeover lapsing and OCP selling down its stake (at 19 cents per share).

The Fund's cash position has been building in recent months, presently at 31%, and set to increase in the next month, all other things being equal, as we realise our investment in the now delisted Emerging Leaders Investment Limited.

We continue to establish positions in new securities as well as adding to some existing holdings where prices remain attractive.

We remain cautious about the global macro outlook, as market conditions remain fertile for sentiment to overshoot value (both up and down). The consequences of the significant macro factors at play globally are difficult to predict or quantify. We remain focused on opportunities that have high levels of tangible assets, marketable securities or cash and whose prospects are somewhat independent of market and economic conditions, as we believe these offer the best risk-adjusted returns in the current environment.

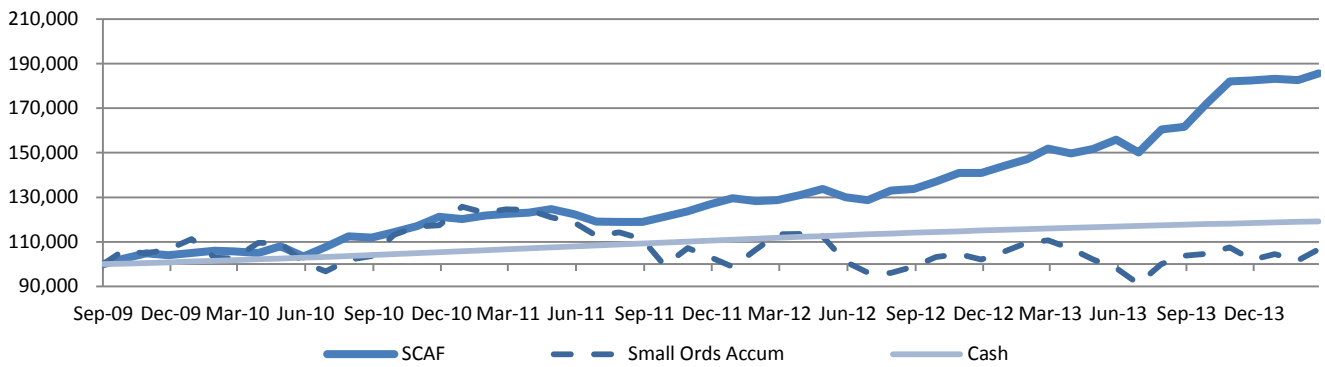

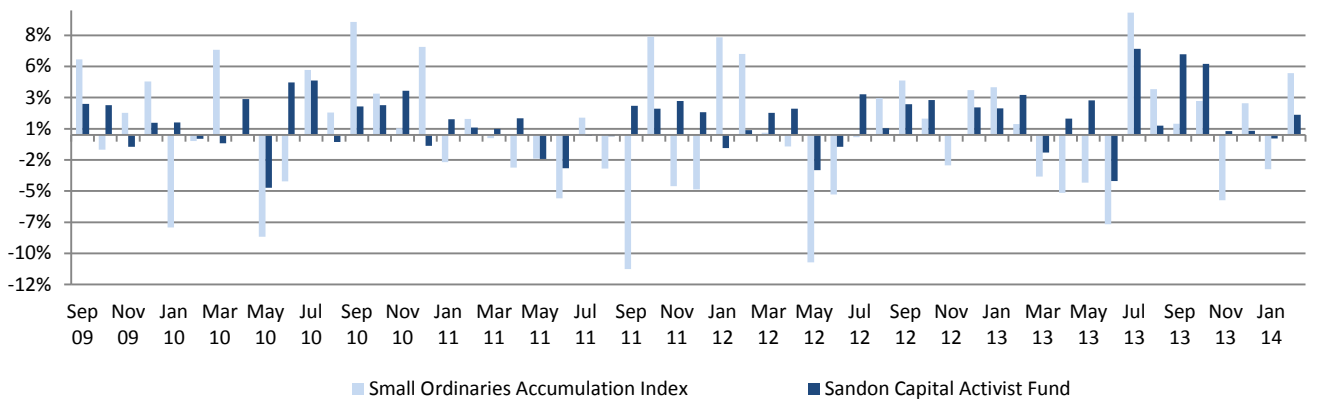

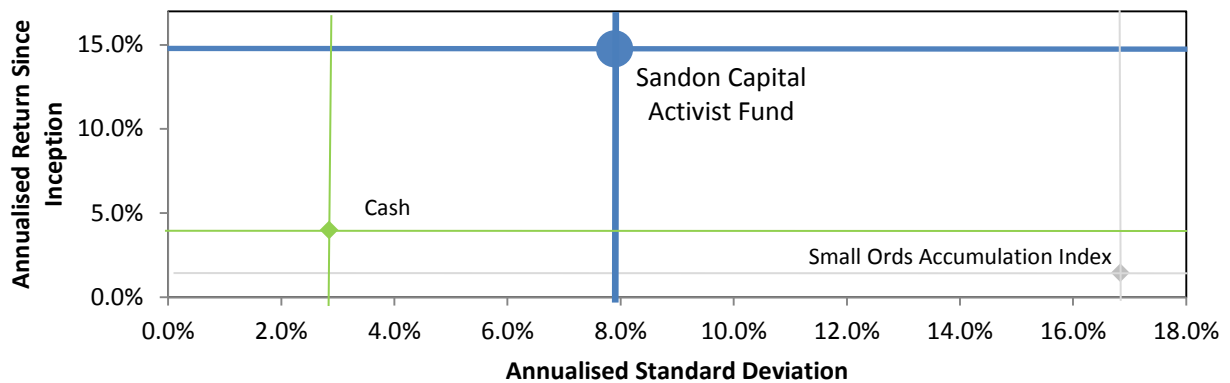
Growth of \$100,000 invested since inception (assumes reinvestment of distributions)
