### Fund Commentary

The Fund delivered a return of 0.3% in November. The most significant contributors to this month's result were Warrnambool Butter and Cheese Factory Holdings Ltd (WCB) whose share price increased more than 10% (~1.0% contribution) and Centrepoint Alliance Ltd, whose share price rose 30% (~0.8% contribution). Keybridge Capital Ltd (KBC) was the recipient of a low-ball takeover offer, which led to a 22% increase in its share price (~0.5% contribution). The positive moves were offset by a few negative results, notably Calliden Group Limited (CIX), whose share price fell 25% (a -2.2% contribution).

The Warrnambool Cheese & Butter Factory Holdings Limited (WCB) saga continued, with Canadian firm Saputo, increasing its offer, but disappointingly removing the prospect for fully franked dividends. Bega Cheese Ltd responded by submitting an application to the Takeover's Panel. Saputo have a distinct price advantage over their local competitors by virtue of their inability, ultimately, to use imputation credits. We would like to see them (or anyone else for that matter) use this advantage.

CIX announced a profit warning, not unexpectedly, as we have held concerns about their \$10m profit forecast. In fairness to CIX, ours were generalised scepticism of their target and not prescience on our part of the challenges in the builder's warranty market. CIX, in our opinion, remains small scale, in an industry where scale matters.

We remain cautious about the global macro outlook, as market conditions remain fertile for sentiment to overshoot value (both up and down). The consequences of the significant macro factors at play globally are difficult to predict or quantify. We remain focused on opportunities that have high levels of tangible assets, marketable securities or cash and whose prospects are somewhat independent of market and economic conditions, as we believe these offer the best risk-adjusted returns in the current environment.

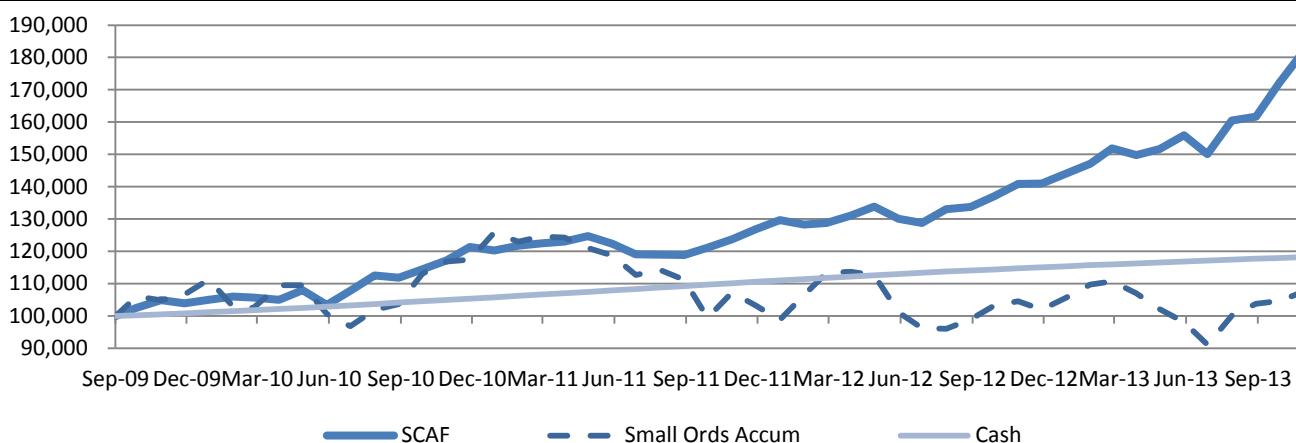

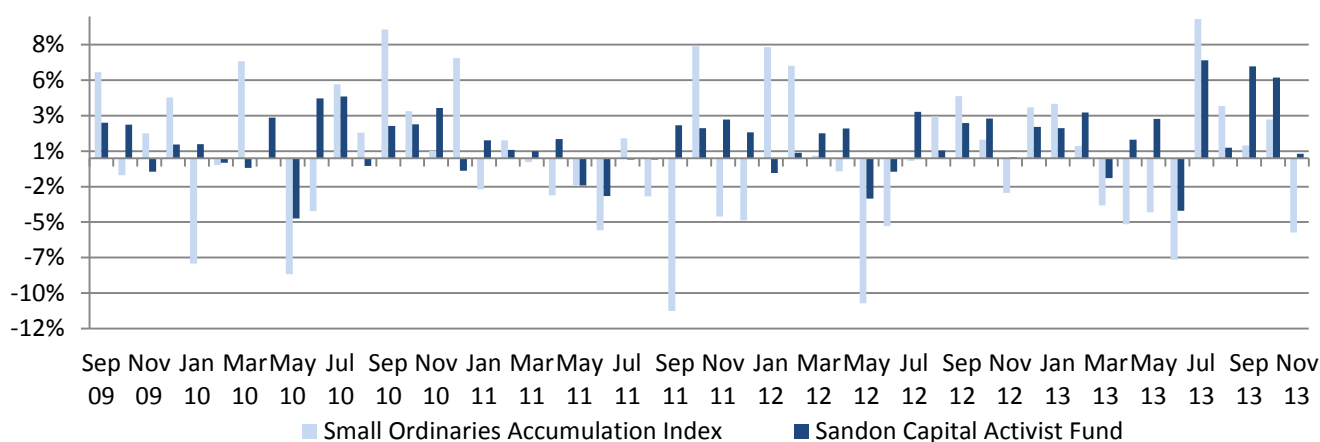

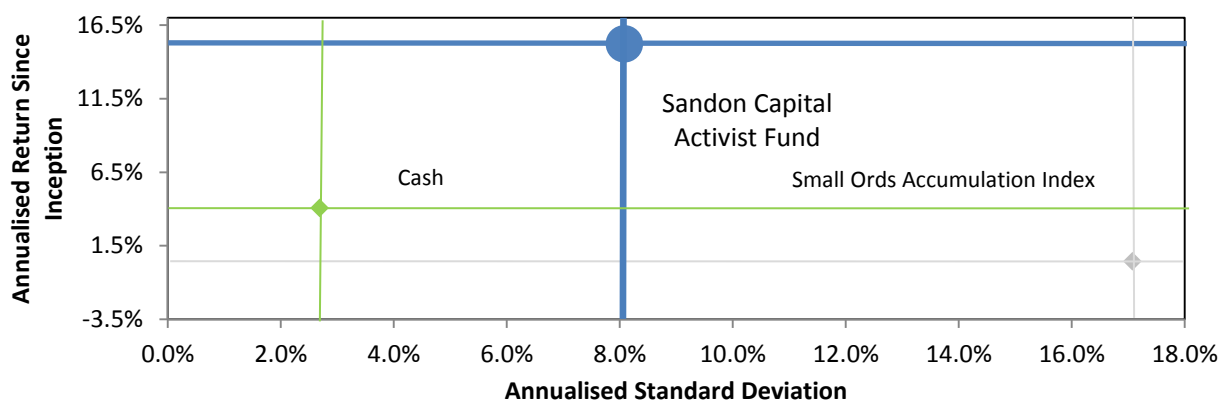
### Growth of \$100,000 invested since inception (assumes reinvestment of distributions)
