#### **Fund Commentary**

The Fund delivered a return of 2.8% in October. The share prices of all but one investment increased during the month. The largest contributors were Centrepoint Alliance Ltd (~0.5%) and Calliden Group Ltd (~0.5%). Both companies' shares rose more than 10% during the month. Ingenia Communities Group fell a fraction (~-0.1%).

During the month, Industrea Ltd (IDL) cleared the remaining foreign regulatory hurdles to the scheme of arrangement proceeding. We are confident it will be approved and deliver the Fund a small profit, but remain deeply disappointed that there were no fully franked dividends paid as part of the scheme consideration. By our calculations, more than 20 cents per share of franking was left on the table.

We exited a number of investments that were subjects of takeovers, schemes of arrangement and returns of capital, all of which delivered modest, low-risk, profits for the Fund. If we include IDL, which should soon convert to cash, the Fund currently has approximately 50% of its assets in cash. This presents us the opportunity to add to some existing positions as well as considering prospective investments.

We have been engaging privately with two companies in the portfolio and are quietly encouraging corporate activity in two others.

We continue to remain cautious about the global macro outlook, though actual (and expected) regulatory responses (that we do not consider solve root problems) can engender significant positive market responses. The consequences of the significant macro factors at play globally are difficult to predict or quantify.


We remain focused on opportunities that have high levels of tangible assets, marketable securities or cash and whose prospects are somewhat independent of market and economic conditions, as we believe these offer the best risk-adjusted returns in the current environment.
